Re: Notice of Intent to File Suit under the Clean Water Act for Violations of NPDES Permit No. AL0074608

Dear Mayor Roy:

Pursuant to the Clean Water Act § 505, 33 U.S.C. § 1365, and 40 C.F.R. Part 135, Subpart A, you are hereby notified that after the expiration of 60 days following service of this notice, Conservation Alabama Foundation, Inc. may file suit against the City of Calera for discharges of pollutants from the Northside Pollution Control Plant at County Road 70 and East County Road 42 into Camp Branch in violation of the limitations and conditions of NPDES Permit No. AL0074608 as reported in Discharge Monitoring Reports submitted by the City of Calera to the Alabama Department of Environmental Management from April 11, 2003 to April 11, 2008, including but not limited to, the following violations:
