

PHILLIPS, JR., to solicit or receive a thing of value as described under Section 36-25-1, of the Code of Alabama, to wit: compensation, from a principal, to wit: DRUMMOND COMPANY, INC., in violation of Section 36-25-5.1(a), of the Code of Alabama, and any one or more of the persons included in said agreement, to wit: ONIS GLENN III, did an overt act, to wit: contract with BALCH AND BINGHAM on behalf of SOUTHEAST ENGINEERING & CONSULTING and/or submit invoices from SOUTHEAST ENGINEERING & CONSULTING and/or accept payment from DRUMMOND COMPANY, INC. for consulting services, and/or direct payment for those services to WILLIE S. PHILLIPS, JR. or any business with which he is associated, to effect an objective of the agreement, in violation of section 13A-4-3, of the Code of Alabama, against the peace and dignity of the State of Alabama.

## Count 2

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, did willfully and knowingly, agree with WILLIE S. PHILLIPS JR., to intentionally use or cause to be used the official position and/or office held by WILLIE S. PHILLIPS JR. to obtain personal gain for WILLIS S. PHILLIPS JR. and said use and/or gain is not otherwise authorized by law, in violation of

PHILLIPS, JR. and/or any other person, or principal campaign committee as defined in Section 17-22A-2, of the Code of Alabama, which would materially affect the financial interest of WILLIE S. PHILLIPS, JR., to-wit: compensation from DRUMMOND COMPANY, INC., in violation of Section 36-25-5(c), of the Code of Alabama, and any one or more of the persons included in said agreement, to wit: ONIS GLENN III, did an overt act, to wit: contract with BALCH AND BINGHAM on behalf of SOUTHEAST ENGINEERING & CONSULTING and/or submit invoices from SOUTHEAST ENGINEERING & CONSULTING and/or accept payment from DRUMMOND COMPANY, INC. for consulting services, and/or direct payment for those services to WILLIE S. PHILLIPS, JR. or any business with which he is associated, to effect an objective of the agreement, in violation of section 13A-4-3, of the Code of Alabama, against the peace and dignity of the State of Alabama.

PHILLIPS, JR. to obtain personal gain for WILLIE S. PHILLIPS, JR. to-wit: compensation from DRUMMOND COMPANY, INC., and said use and/or gain is not otherwise authorized by law, in violation of Section 36-25-5(a), of the Code of Alabama, against the peace and dignity of the State of Alabama.

## Count 6

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, did aid or abet a public official, to-wit: WILLIE S. PHILLIPS, JR. in soliciting

or receiving a thing of value as described under Section 36-25-1, of the Code of Alabama, to wit: compensation, from a principal, to-wit: DRUMMOND COMPANY, INC., in violation of Section 36-25-5.1(a), of the Code of Alabama, against the peace and dignity of the State of Alabama.

## Count 7

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, did aid or abet a public official, to-wit: Commissioner with the ALABAMA ENVIRONMENTAL MANAGEMENT COMMISSION, WILLIE S. PHILLIPS, JR. to-wit: compensation from DRUMMOND COMPANY, INC., in violation of Section 36-25-5(c), of the Code of Alabama, against the peace and dignity of the State of Alabama.
